



BUILDING ALL CHILDREN, INC. VOLUNTEER AGREEMENT AND RELEASE FROM LIABILITY

1. I, (guardian) _____, give my child, (minor) _____, permission to serve Building All Children, Inc. as a volunteer at events hosted by Building All Children and located at various premises including but not limited to the Building All Children office, First Baptist Church Jenks, Asbury United Methodist Church, Southern Hills Baptist Church, and Abiding Harvest Church.

2. As a volunteer, I understand that I control the dates and times when I and/or my minor do the work and that Building All Children is not responsible for scheduling the volunteer work. I also understand that there will not be compensation for any time spent volunteering, nor am I and/or my minor entitled to benefits, including employment insurance benefits upon the termination of this agreement or as a result of this service.

3. I am aware that participation as a volunteer may require periods of physical requirements, i.e. standing, lifting and carrying up to 40 pounds and will require the exercise of reasonable care to avoid injury. The minor is voluntarily participating in this activity with knowledge of the hazards and potential dangers involved, and agrees to accept any and all risks of personal injury and property damage.

4. As consideration for volunteering for Building All Children, I hereby agree that I, and my assignees, heirs, minors, guardians, and legal representatives, will not make a claim against or sue Building All Children or its employees, agents or contractors for injury or damage resulting from the negligence, whether active or passive, or other acts, however caused, by any of its officers, employees, agents, or contractors of Building All Children as a result of my volunteering. I HEREBY RELEASE AND DISCHARGE BUILDING ALL CHILDREN AND ITS OFFICERS, EMPLOYEES, AGENTS AND CONTRACTORS FROM ALL ACTIONS, CLAIMS, OR DEMANDS THAT I, MY HEIRS, MINORS, GUARDIANS, AND LEGAL REPRESENTATIVES NOW HAVE, OR MAY HAVE IN THE FUTURE, FOR INJURY OR DAMAGE RESULTING FROM MY OR MY MINOR'S PARTICIPATION IN THE PROJECT.

5. I UNDERSTAND THAT IF MY CHILD/MINOR IS INJURED IN THE COURSE OF THE PROJECT, HE OR SHE IS NOT COVERED BY BUILDING ALL CHILDREN'S WORKERS' COMPENSATION PROGRAM. I authorize Building All Children to seek emergency medical treatment on my behalf of my child/minor in case of injury, accident or illness to him or her arising from his or her involvement as a volunteer. I understand that I will be responsible for medical costs incurred by such accident, illness or injury.

6. I understand that the materials and tools provided by Building All Children are and remain the property of Building All Children, and I agree to return these tools and any remaining materials to Building All Children at the end of my volunteer service.

7. I HAVE CAREFULLY READ THIS AGREEMENT AND FULLY UNDERSTAND ITS CONTENTS. I AM AWARE THAT THIS IS A RELEASE OF LIABILITY, AND SIGN IT OF MY OWN FREE WILL.
