



**BUILDING ALL CHILDREN, INC.
VOLUNTEER AGREEMENT AND RELEASE FROM LIABILITY**

1. I, _____, agree to work for Building All Children, Inc. as a volunteer on written reports, BAC blog, and any administration or written documents. I understand that these items need to be proof read and returned within two days. I also, understand that anything I read is confidential and should not be shared with anyone. This contract is a written document giving me permission to read confidential reports from Building All Children.
2. As a volunteer, I understand that I control the dates and times when I do the work and that Building All Children is not responsible for scheduling my volunteer work. I also understand that I will not be compensated for any time spent volunteering, nor am I entitled to benefits, including employment insurance benefits upon the termination of this agreement or as a result of this service.
3. I am aware that participation as a volunteer may require periods of physical requirements, i.e. standing, lifting and carrying up to 40 pounds and will require the exercise of reasonable care to avoid injury. I am voluntarily participating in this activity with knowledge of the hazards and potential dangers involved, and agree to accept any and all risks of personal injury and property damage.
4. As consideration for volunteering for Building All Children, I hereby agree that I, and my assignees, heirs, guardians, and legal representatives, will not make a claim against or sue Building All Children or its employees, agents or contractors for injury or damage resulting from the negligence, whether active or passive, or other acts, however caused, by any of its officers, employees, agents, or contractors of Building All Children as a result of my volunteering. I HEREBY RELEASE AND DISCHARGE BUILDING ALL CHILDREN AND ITS OFFICERS, EMPLOYEES, AGENTS AND CONTRACTORS FROM ALL ACTIONS, CLAIMS, OR DEMANDS THAT I, MY HEIRS, GUARDIANS, AND LEGAL REPRESENTATIVES NOW HAVE, OR MAY HAVE IN THE FUTURE, FOR INJURY OR DAMAGE RESULTING FROM MY PARTICIPATION IN THE PROJECT.
5. I UNDERSTAND THAT IF I AM INJURED IN THE COURSE OF THE PROJECT, I AM NOT COVERED BY BUILDING ALL CHILDREN'S WORKERS' COMPENSATION PROGRAM. I authorize Building All Children to seek emergency medical treatment on my behalf in case of injury, accident or illness to me arising from my involvement as a volunteer. I understand that I will be responsible for medical costs incurred by such accident, illness or injury.
6. I understand that the materials and tools provided by Building All Children are and remain the property of Building All Children, and I agree to return these tools and any remaining materials to Building All Children at the end of my volunteer service.
7. I HAVE CAREFULLY READ THIS AGREEMENT AND FULLY UNDERSTAND ITS CONTENTS. I AM AWARE THAT THIS IS A RELEASE OF LIABILITY, AND SIGN IT OF MY OWN FREE WILL.
